#### **EVALUATION RECOMMENDATIONS & ACTIONS 2013-14**

- Strengthen BCOP Leadership new BCOP Executive Committee, Chair and Deputy Chair established after Bohinj meeting in 2012.
  - Are more Exec Comm members needed?
  - Is there interest from other BCOP members to join this Committee?
- More knowledge products Representatives from BCOP Exec Comm have had close consultation with OECD on Budget Surveys. Possibility of expansion of survey to more PEMPAL countries.
  - Are there other products, research that would be useful to you?

#### **EVALUATION RECOMMENDATIONS & ACTIONS 2013-14**

- Establish BCOP short, medium and long term objectives - in context of PEMPAL Strategy 2012-17 results framework and results of World Bank PFM study.
  - When and How?
- Ensure quality membership Monitor membership to ensure target members are attending BCOP events
  - Important to donors to ensure funding is being spent on right people
  - Important to BCOP to ensure network is strengthened and we bring same people together regularly from similar areas to discuss issues



#### MEMBERSHIP ANALYSIS RESULTS

- Attendance at BCOP events analysed for last 2 years (ie Cross-COP Zagreb meeting on managerial accountability, BCOP plenary on capital budgeting in Minsk, BCOP plenary on program budgeting in Bohinj)
- Despite data constraints, appears that BCOP events are attracting target membership (ie budget related officials from Ministries of Finance at both Budget Director and technical levels)
  - Attendance by political levels (Assistant Minister and above) low. Do we want to target more participants at this level?? NB:Investigations underway of feasibility of establishing separate higher level forum.
- Increasing trend of participation. 35 BCOP members in Zagreb, 43 in Minsk, 56 in Bohinj, 58 in Tirana. Repeat participation high. PEMPAL Independent evaluation recommends more proactive approach to membership needed.



## **MEMBERSHIP ANALYSIS - FUTURE**

- Analysis impeded as information provided by participants on functional area of work often unclear
  - Information on participants improved for Tirana meeting by redesign of Secretariat event invitation form
- Lists of Participants will be analysed after every event
  - Summary provided to BCOP Executive Committee and PEMPAL Steering Committee. Membership strategies developed where necessary.
- Analysis of MoF organagrams currently underway to provide information to inform future invitation process
