#### 1. Program for 2007

# 1.1. Activities which can be performed by the group with the support of PEM-PAL and the World Bank:

- 1.1.1 (**Stage One**) Prepare a questionnaire to study the needs of Ljubljana Seminar participants for internal audit pilot projects *February-March*
- 1.1.2 (**Stage Two**) Process the questionnaire survey results and submit them to PEM-PAL *April*
- 1.1.3 (**Stage Three**) Prepare brief information about supply and demand in the area of internal audit pilot projects *May-June*
- 1.1.4 (**Stage Four**) Prepare draft indicators to evaluate the outcomes of internal audit pilot projects *second half of 2007*.

Person in charge of Stages 1-4: Ms. Marina Barynina, Project Manager

Specific activities (steps) and periods of execution of Stages 1-4 are described above.

**Key conditions:** Support provided by PEM-PAL and the World Bank during translation, specification, and distribution of:

- questionnaires;
- results of the questionnaire survey;
- brief information about supply and demand; and
- draft indicators for evaluation of the internal audit pilot project outcomes.

A stage can be considered complete on the date when the respective aforesaid document is delivered.

## 1.2. The issues which require extra logistic support and funding:

- support in preparation of the plans (terms of reference) and the cost estimations of pilot projects;
- search of experienced government (internal) audit practitioners pilot project managers from the EU Member States;
- funding of the pilot projects (search of sponsors and donors) and support of the World Bank; and
- training (during the pilot projects) of future trainers for new internal auditors.
