PEM PAL BCOP PLENARY IN ARMENIA FEEDBACK SURVEY

On February 11-13, 2015 BUDGET COMMUNITY OF PRACTICE (BCOP) met to discuss Fiscal consolidation in Yerevan, Armenia.

After the event, the on-line survey in three languages was created. The aim of the survey was to receive event feedback.

The survey started to collect responses on February 16 and finished on March 02, 2015. Invitations to take part in the survey were sent to 53 participants of the meeting.

23 responses were received (43,4%). In this report, we analyze all 23 responses. For further calculation, we take this quantity as 100%.

All these responses will be included in the general Feedback Event Database. All responses are not identified by source and sent on a confidential basis to Nina Duduchava of the World Bank who prepares this report.




This question was seen only by those respondents who chose "No" in the previous question. 15 respondents answered this question.

Q16. What did you not like most about the event?

8 informative comments were left. 3of them is a comment: "I liked everything" For example: Everything was well organized.

It means that there is 5 comment about elements which were not like by participants.

<u>Very little time to summarize the presentation and discussion in groups. Strange format.</u> Fits all does not happen, rather it is necessary that each participant prepares proposals for their country.

Discussion went outside of the scope of the topic we were supposed to discuss.

Q20. How can you apply the acquired knowledge?

- 4. In this moment in Croatia we have in-depth analysis of expenditure (expenditure reviews) performing by expert teams organized for this purpose, under the direct coordination of the State Treasury where I work. These meetings provide an appropriate framework and a foundation upon which to fiscal consolidation measures be implemented, but each country, in my opinion, must determine their specificity and to develop their own measures and tools that match in the process.
- 5. In preparing the results of inspection teams who worked on the review of expenditures and in preparing the budget for next year.
- 6. Trying to influence specific decisions
- 7. I will be able to, when proposing measures for expenditure savings in the budget of the Republic of Serbia. In addition to the proposed fiscal consolidation measures we will necessary to look at the possibility of applying measures that are applied in other countries.
- 8. As I train the specialists in public finance sector, the acquired knowledge could be used for my teaching materials
- 9. The combination of adjustment expenses / income
- **10.***I* intend to use bibliographical materials to redefine some performance indicators.

Answered question -20 (87%). And 75% of the respondents (16) considered themselves as 'highly satisfied'. Rating given by 4 persons (25%) was "4". Average rating is 4.8.

RECOMMENDATIONS FOR THE FUTURE

Q22. Do you have any suggestions to improve the content, approach and other aspects of such events in future?

8 comments were left and 3 of them consist suggestions.

- 1. I suggest to have in addition to standard pre-event survey to ask each country (or PEM PAL on behalf of the each member country) filled the specific schemes describing the financial and economic situation in the country (macroeconomic indicators, deficit, employment, average salary, etc.) if they exist in the form of a standardized questionnaire
- 2. "1. More work in groups 2. Recommendations from the expert side for each country"
- 3. Probably it would be useful to change the time dedicated for working groups.

Q23. Are there any other products, research or services that PEMPAL could provide that would be useful for your work?

8 informative comments were left.

- 1. It would be good to have another products for use in our work
- 2. -Bibliographic resources
- 3. It will be great to be announced about new additions to the library (for example which informational materials were added)
- 4. Management of capital projects
- 5. Yes. Sometimes we need to study the experience of other countries. In such cases, PEMPAL could organize a video conference with the participation of a country that has a positive experience for specific issue.
