PEM PAL BCOP Workshop on Budget Literacy FEEDBACK SURVEY

On May 20th, 2015, the PEMPAL BCOP Budget Literacy workshop took place in Warsaw, Poland. After the event, the on-line survey in three languages was created. The aim of the survey was to receive event feedback.

The survey started to collect responses on May 25 and finished on May 29, 2015.

Invitations to take part in the survey were sent to 16 participants of the workshop.

11 responses (68.8%) were received. In this report, we analyze all 11 responses. For further calculation, we take this quantity as 100%.

All these responses will be included in the general Feedback Event Database. All responses are not identified by source and sent on a confidential basis to Nina Duduchava of the World Bank who prepares this report.



This question was seen only by those respondents who chose "No" in the previous question. 7 respondents answered this question.



Q7. Describe your own level of expertise, as compared to that of other participants?

8 comments were left.

- 1. All countries in varying degrees have a policy on budget literacy and citizen participation in the budget process.
- 2. I iparticipate in all budget processes in my country. So I think that my level of knowledge in this area is high, but also the level of knowledge of most participants was high.
- 3. The participants were generally competent in the workshop topic, which allowed the exchange of experience not only during the presentations, but also during informal communication. Not the big rating for option (c) is related only to the fact that the approaches in addressing the issues raised in the different countries are not the same.
- 4. I was very impressed by the organization and professionalism of the event, the scope of the information provided and the enthusiasm of the participants.
- 5. I have been working at Budget Department for more than 6 years. Other participants have also spent more or less the same 6 years or more than this years
- 6. The experience of the Russian Federation in the sphere of budget literacy is considered significant, we will be happy to share our experiences with the WG participants at the next meeting. We think UK and Canada experience in this sphere very useful
- 7. Russian approach to the construction budget for the citizens for different target groups, and other participants have many years of experience with the individual target groups. In budget literacy Russian side has more attention to all the budget expenditures and revenues, other participants pay more attention to taxes.
- 8. It was quite OK.

Q8. What have you learned from other participants?

10 comments were left.

- 1. The importance of the themes in the budget system of any country was highlighted and justified, the good practice of introducing mechanisms of information for citizens and their results were clearly shown.
- 2. Some countries have more experience in the field of budget literacy. Most interesting for me was that already in middle school there are conducted training on understanding the budget and the budget process. Our Ministry has not taken any actions related to cooperation with schools and universities in order to improve knowledge of the budget process.
- 3. Different approaches to budget literacy were very interesting ranging from an NGO in Canada engaging students in budget formulation process including given them opportunities to present their views to Minister of Finance; to UK and the HRM Revenue Service preparing animated media advertisements on how important it is for citizens to pay taxes; to Russian Federation's citizens budget project whereby they are finding out information needs and gaps for different target groups for budget portal and also developing curriculum for schools. The results of pre-workshop survey were also very interesting as showed status of reforms in 14 of the 15 countries participating in the BCOP Budget Literacy Working Group.
- 4. Most useful for me was the experience of Russia and the UK in terms of ensuring the availability of the budget for all citizens, irrespective of membership in any social group or level of education
- 5. That there is no prescribed mechanism for budget literacy, it is about making it appropriate for the culture of each country.
- 6. Their implementations about budget literacy
- 7. Important details in material presenting, visualization
- 8. I noted Important details in material presenting, visualization, expanding coverage
- 9. Presentations were made very interesting with different video and audio materials, the experience of the Russian Federation, the United Kingdom, Canada was interesting and useful, during the discussions, questions-answers further clarification on the topics of presentations were received.

Information received suggests that the countries (an example of which the presentations were made) are still at the stage of searching for optimal tools and approaches to improve budget literacy and budget availability. At the same time there was no information about how civil society is satisfied with the results and how the state intends to organize (improve) a dialogue with society on budget matters.
- 3. We hope to continue to study international experience in improving budget literacy of citizens, openness and accessibility of the budget in the next WG meetings.
- 4. During the event we acquired a good idea of global experience and planned subsequent study of it/ It is too early to speak that we have already learned it.
