




TCoP plenary workshop in Baku, Azerbaijan, on the topic "Public Sector Accounting Policies and Practices", November 2012. <u>63</u> participants from <u>18</u> countries attended the workshop.



TCoP study visit to the Ministry of Finance of Estonia, on the topic "Public Sector Accounting and Reporting reforms" February, 2013. **13** participants from **6** countries attended the event.



TCoP plenary workshop in Kiev, Ukraine, on the topic "Internal Control and the Role of a Modern Treasury", April 2013. <u>65</u> participants from <u>18</u> countries attended the workshop.

Examples of Results Achieved

- ✓ Good practices in implementing treasury information systems identified and show cased (agendas of events held in Kazakhstan, Georgia, Russia and Azerbaijan included live demonstrations of treasury IT systems)
- ✓ Peer advise provided to countries designing new charts of accounts (*Tajikistan, Ukraine*)
- ✓ Member countries applied for technical assistance funding based on information received from PEMPAL (Kazakhstan, Belarus)
- ✓ Bilateral agreements on peer exchange signed between the MoFs / treasuries of member countries (*Russia Ukraine, Russia Kazakhstan, etc.*)
- ✓ Contacts established with the MoFs of France, Netherlands, South Korea, Estonia

BC and CoA thematic group

Created in November 2012

Main objective:

Methodological support to the countries interested to integrate their CoA and BC based on international standards

What has been done:

- Review of the status of BC and CoA integration in the member countries
- Draft CoA of Ukraine reviewed and commented

<u>Developed documents</u>:

- ✓ Review of the economic classifications
- ✓ Comments to the Chart of Accounts.
- ✓ Expert presentations addressing the questions raised by the group members
